- 4. **Bid Security Declaration**: The Bidder will furnish a Bid Security Declaration to the effect that if the bid is withdrawn or modified during period of validity or if after being awarded the contract the bidder fails to sign the contract, or fails to submit a performance security before the deadline defined in the request for bid document, the bidder will be suspended for a period of 180 days for contracts with the High Commission of India, Maputo.
- 5. Bids can be submitted on any working day from 14-01-2022 to 07-02-2022 (from 0930 hrs to 1700 hrs).
- 6. The Bids will be opened at 1100 hrs on 9<sup>th</sup> February 2022 at No. 167, Av. Kenneth Kaunda, Maputo by the Committee authorized by the Competent Authority of this High Commission. All the Technical Bids will be opened first. Bids that are not compliant with the technical specifications of equipment and the eligibility conditions of the Tender document will be discarded. The financial bids of only those bidders who pass the Technical Bid evaluation will be opened next. The successful bidder will be decided on the basis of the lowest price quoted.
