NOTICE INVITING TENDER

The High Commission of India, Maputo invites Tender under two bid system from registered and authorized firms/ agencies for supply and installation of one hundred two (102 units of Desktop Computers, 23 Black and White Laser Printers and 2 Multi-function Ink-Jet colour printers with scanner to the High Commission of India, Avenida Kenneth Kaunda, No. 167, PO Box 4751, Maputo, Mozambique as per the specifications given in the tender documents.

2. The tender document can be downloaded from our website <https://hcimaputo.gov.in/> or from Central Public Procurement Portal <https://eprocure.gov.in/cppp/> No fee for Tender Document will be charged.


3. The interested firms/ agencies have to submit their offers in two bid system i.e., (i) Technical Bid and (ii) Financial Bid. Bids are to be submitted to the Head of Chancery, High Commission of India, Avenida Kenneth Kaunda, No. 167, PO Box 4751, Maputo, Mozambique. All the necessary documents including those in support of eligibility criteria etc. (except the Financial Bid) are to be submitted along with the Technical Bid in a sealed envelope. The financial Bid must be submitted in a separate sealed envelope. No bid will be accepted after the expiry of stipulated date and time for the purpose under any circumstances.

4. **Bid Security Declaration:** The Bidder will furnish a Bid Security Declaration to the effect that if the bid is withdrawn or modified during period of validity or if after being awarded the contract the bidder fails to sign the contract, or fails to submit a performance security before the deadline defined in the request for bid document, the bidder will be suspended for a period of 180 days for contracts with the High Commission of India, Maputo.

5. Bids can be submitted on any working day from 14-01-2022 to 07-02-2022 (from 0930 hrs to 1700 hrs).

6. The Bids will be opened at 1100 hrs on 9th February 2022 at No. 167, Av. Kenneth Kaunda, Maputo by the Committee authorized by the Competent Authority of this High Commission. All the Technical Bids will be opened first. Bids that are not compliant with the technical specifications of equipment and the eligibility conditions of the Tender document will be discarded. The financial bids of only those bidders who pass the Technical Bid evaluation will be opened next. The successful bidder will be decided on the basis of the lowest price quoted.

7. The High Commission of India, Maputo reserves the right to reject any or all the bids without assigning any reason and the decision of the High Commission shall be final and binding.
